Good morning to all. Welcome to the Fall Region Service Committee meeting in Huntsville, Texas. For those of you who don't know I recently moved to the "big thicket" near Livingston. Ilive about an hour east and a bit south of this morning's meeting. Welcome to the land of woods, lakes, wildlife and parks. In the past quarter there was a conference participant webinar concerning the Independent Discussion Topics (IDT's) that were the most supported items from around the world at the last World Service Conference. The two topics that floated to the top based on input from individuals and Regions and Zones are disruptive and predatory behavior, and inclusive language. The Region had a workshop a few weeks ago concerning these items. The meeting was hybrid - in person and online - and several members attended. The most common response was that these topics are important to the fellowship, and more discussion about them is supported by members of the Region.

This last quarter I attended several ASC meetings and worked to provide information and support to the Areas to the best of my ability. I attended a few of the subcommittee meetings of the Region and am truly grateful to be able to participate online.

Narcotics Anonymous World Services is preparing to transition from listing every meeting around the world on their website to providing links to the websites for Areas and Regions so that members can search for meetings near them wherever they may be. I sent a few emails to NAWS seeking to update the information that they have, and I sent some emails to the Region asking that each Area check their websites to insure that they are current and accurate. This afternoon at 1 PM there will be a webinar concerning updating websites and helping improve the search process for meetings. I will be stepping out of the RSC to participate in that webinar.

- o IDTs information released by World, 9/23/23.
- o The new IDTs information was released at this meeting. The meeting started with 152 participants and ended with 166 participants.
- o THE WCNA39 convention information will be released at the end of the year. Remember that we are short staffed and logistics are a little behind.
- o Please hold off on renting air bnbs and hotels near the convention site. There will be plenty of rooms for everyone who is attending.
- o The next IDTs will be released on 11/18/2023.
- o The next CP meeting will be 12/2/23.

o Reminder to fill out the survey https://www.surveymonkey.com/r/23-24_environmental_scan you can complete as a member or area. Deadline to complete is 11/15/2023. The results will affect how the conference will move forward in the future.

• US Zones meeting, 10/2/23.

- o Recap, the latest surveys results are moving forward. This was the latest decision recommended for the US collaboration. After obtaining 80% support of the US regions. (67 regions).
- o We have created draft guidelines that we will continue to work on.
- o None of this is written in stone. The structures and functions of this collaboration will be written and defined by its members and ratified by its member zones.
- o We will build this together. Please go to https://usa-na.org/tell-us-what-you-think/ and complete the survey.
- o The next two meetings will be 11/16/2023 @ 7pm (CST) and 11/27/2023 @ 6pm (CST). Come be a part of and everyone is welcomed to participate. Virtual information: Zoom 449 253 6438, no password o As of today, 42 of the 67 regions have responded.
- o 30/Yes, 5/No and 7/PNV; 86% support of those who responded, presented information about US collaboration during NEFZ business meeting.

• SZF meeting on Monday before the MZSS.

- o We have filled the following positions:
- i. Scott M., Facilitator, Show Me Region,
- ii. Zonal Delegate, Scott, Kentucky
- iii. FD Coordinator, Kristen D., St. Louis
- iv. AV Coordinator, Mark, Arkansas
- o It appears there is a cost to set up a 501.3c so the SZF can accept donations from the Volunteer region. Scott will research for an agent to assist with this process.
- o We decided to meet on the Monday before the MZSS in Detroit which provided a virtual platform for the meeting. We conducted business and did our zonal reports. That was the extent of the business. We met again on Sunday at the conclusion of the MZSS. I was able to participate until I had to leave for the airport. I then listened in until my flight left.
- o At the next zonal meeting we will conduct a zonal inventory that will be facilitated by Cindy from Oklahoma and Craig R. from North Carolina (former World Board/HRP member) which will be conducted on Friday evening at the opening portion of the SZF, which will be held on January 26-28 in St. Louis. The Show Me Region will host the Winter SZF 2024 forum. See attached flyer.
- o One of the regions reported they may be moving on and our zonal representative is from that region. This is something that will need to be addressed once they make their decision in January 2024.
- o On 11/4 we conducted a virtual meeting to report back to the World Board on our environmental scan as a zone. If you would like to know the results, I have them with me.
- o I had a lengthy conversation with a former Board member regarding how we reach a consensus of the scan.

• MZSS event.

o This was a great experience. I learned a lot and attended many workshops with various topics. o I also attended workshops on the IDTs. It was the first time the WSO sent a travel team. Danny G. (World Board Chair), Steve R. (from the office), Daniel (former Conference Facilitator), who now

works for NAWS, and Laura (former Co-Facilitator for Conference).

- o It was very informative. Ideas where shared that had not been discussed before and more information was provided.
- o I brought various handouts (see back table) and different key tags from around the world.

- o Soon you will be able to listen to all the workshops online, they were all recorded.
- o One suggestion I made to the MZSS was to release the virtual meeting information once the meeting started. There were only 2-3 people online during the virtual workshops at different times over the weekend.
- o Some of the information released was that pamphlet #1 and key tags have been translated into the language of the Navaho nation for the first time in our history.
- o Some of the other things discussed is that the words men and women don't appear in the Living Clean book. The book is more inclusive and is a snapshot of the current fellowship.
- o The small groups were fun, exciting, and informative That is where the creative action is born in this type of setting. Great notes were taken.

o Other things to report:

- o Jimmy started the World corporation of NA in 1976.
- o Today we have 66 regions in the US. We seated 5 new regions at this year's conference cycle. This means that we have more regions that are seated outside of the US. We are starting to become a worldwide fellowship.

- o We have been running on 90% of income from literature sales.

It is time for me to formally thank this body for electing me onto the admin committee almost five and a half years ago as co-facilitator. This has been an amazing journey in my recovery. I have seen the worst in individuals some with the best intentions for the new way of life we have found in NA (self-included). Moreover though I have been blessed in a conscience based process where individuals come together guided by spiritual principles conducting the business that supports the Groups to carry the NA Message (our sole purpose).

As facilitator, policy states I did not have a vote, and should step aside to express my opinion on any issue at hand. From this, I learned that I not only had an opinion on many issues, but much more strongly I have a clear procedural mandate on the process of coming to conscience. The NA Tradition and Concepts of Service are the backbone of this procedure.

I agree that it is less convenient for the speaker to have to walk to the lectern for a microphone, but it will be much more respectful to the online members if we make this effort to improve how we communicate.

I missed the September Texas State Convention Advisory board meeting. I worked late, but in actuality I had simply forgotten the date. I owe that committee amends. I did, however, offer to do some formatting of their policy as their policy chair had reached out for help with that formatting.

I was asked by a member to chair the RGVNA Area Service committee and actually to join that committee as its facilitator. - Section 7: Financial
- · Hard numbers for admin & subcommittee budgets have been added back into policy I believe the discrepancy between convention guidelines and regional policy regarding when a convention facilitator is voted in will be addressed by a proposal during the RSC meeting from someone actively involved with the convention.

The acting Chair of the Aggieland Recovery Roundup convention (formerly AAggieland Convention) Presented to Area the plan and scope of this newly reformed recovery convention. He made it clear that new format created new challenges in the relationship with the various 12 Step fellowships (the 6th Tradition). He made it clear that all donations would be on an individual basic and corporate support and committee fund raisers. It was discussed that PI could be given a time slot for a formal panel presentation and that this venue would be a good opportunity for the Regional PI tri fold booth. We discussed the NA as such involvement, the 6th Tradition announcements of this event at a group level and as an Area we serve the groups. Thus, the decisions on this matter are up to the groups to confirm that we can do things like announce that there is a PI presentation happening at this event or the Regional PI booth (if done) is there. (or not?)

2 conclusions:

1 There is a clear difference what individuals can do to participate in this new recovery event in our Area and the NA traditions protecting the fellowship even when it might seem like good idea. 2 We need help from the region, other Areas with experience with Recovery Events in making better chooses within the NA structure in our Area. The integrity of the NA message critically important. But our area suffers from addicts seeking recovery in the other fellowship and this might be a venue to improve the perception of the local NA community. Subcommittee Reports

Adopt An Inmate Facilitator: Herb M. -

Adopt An Inmate (AAI) sent out 19 basic texts this quarter. It is interesting to note that 79% of requests came from women inmates, which seems to be the trend since I have been facilitator. Ron S. from HASO has assured me all orders have been mailed out.

The AAI Subcommittee meeting was initially scheduled virtually for October 26, 2023, but had to be cancelled due to technical difficulties. The virtual meeting was rescheduled for November 2, 2023, and 3 total members (me included) were in attendance. We reviewed and edited the letter we will be sending out to the Kenedy Warden about providing a basic text to the facility, preferably in electronic form (mailed out 11/3/23). As you may recall, this was set in motion by a letter from an inmate requesting 50 basic texts. In August, I sent a letter to this inmate explaining that we will be reaching out to the administrators at the Connally Unit to discuss the best process for providing NA literature to the facility.

In addition, I sent him a basic text. I have attached both these letters to this report.

We also discussed sending a similar letter to other prison units in Texas asking if we can provide NA literature to them, preferably electronically.

Lastly, the AAI Subcommittee needs support. At our next subcommittee meeting I will open nominations

for Co-Facilitator. My term is ending in early to mid-2024 and do not plan on running for this position again.
