Hello Family,

I am happy to be here today. I have spent the past quarter getting my feet wet and trying to get acclimated to fulfilling the expectations placed on this position. Not sure I met that expectation this time, but I will get better.

One thing that I know I was able to accomplish, was attending the Southern Zonal Forum in Memphis. I am pleased to be able to share with you information recently gained at this Forum. It was an exciting weekend! We covered a lot of information; including topic discussions on "Fund Flow", "Who's Missing From Our Groups and Why" and we were also presented with the new Public Relations Handbook. This handbook is meant to replace the Public Information Handbook. Each presentation had its own way of getting

the "audience" involved in the process, for that hands on feel. It is my perception, from the forums and information that I have received, that we as a fellowship are gearing into a new way *of looking* at service. Through the presentation of the Public Relations Handbook we were given challenges to solve. The main idea is to get "US" thinking about what the BROAD GOAL is; setting a detailed action plan to reach this goal and then develop measures to identify when the goal has been accomplished. This can help us with setting priorities, identifying what works and what does not and giving suggestions and/or outlines for future goals.

I truly enjoy the way this process gets members involved so that we can get a working understanding of the topics and find new ways to share this information with others.

Also I have been made aware of a committee that calls themselves Writing Steps for Recovery Sub Committee. This committee is from Show-Me Region and gives incarcerated recovering addicts another way to work the 12 Steps with a member of this committee. For all those interested I have a handout given to me by one of their subcommittee members. They were present at the last SZF and anxious to answer questions and find other interested members.

This brings me to a question.

One of the things that is repeatedly brought up in various service forums that I attend, is the responsibility of trusted servants to pass on valuable information to others in the service structure so that the most important members can get this information: *the members in our home groups that are not sitting in service meetings*. With that, I ask, how would this body like for me to present information gained at the Southern Zonal Forum? What is most important to me, is that no one need question the value of addicts gathering to share and gain new information. That all those interested in this information have access. I am willing to take suggestions and look for the most beneficial ways of sharing the information gained.

I have turned in receipts for travel to the forum in Memphis in the total of \$587.26. (Hotel-\$143.00; registration and CD set- \$35.00; Food- \$94.48; Gas- \$314.78)

I have previously received \$250 and I am requesting the balance of \$337.26 be reimbursed today. I will also be asking for travel to RSC reimbursement today.

In this next quarter I will be traveling to Serenity in the Sand as directed last RSC. I would appreciate some idea of what to be prepared to present at this event.

The next SZF will be held in Covenington, LA in October.

Co-Facilitator Report-

Co-Fac Report August 9, 2008 RSC – Brenham, Texas

I attended the Texas State Convention Advisory Board meeting (TSCAB) which was held in Austin, Texas July 5, 2008 at noon. I had hoped to attend our (TBR ad hoc meeting on the convention guideline) meeting which was about 4 miles away at 2:00 PM. However, due to a late start (meeting didn't begin until 1:45 PM) this meeting lasted until 7:30 PM. This was also the case with the meeting I attended in April as it started an hour and a half late. The meetings are supposed to begin at noon.

The TSCAB is still in the process of rewriting their guidelines. This year they have a lot of their experienced members rolling off the Advisory Board so they are in the process of changing their guidelines so this doesn't happen again. They had there elections for chair, vice chair, member at large, and treasurer at this meeting and will have more elections October 11 at their next Advisory Board meeting in San Angelo, Texas. This will be about a 220 mile trip one way. My intention will be to leave Friday afternoon and come back Sunday. The projected cost for this trip is \$125.40 for gasoline (if gas remains at 3.95 per gallon) Room at Americas Best Value Inn \$118.80 (2 nights); Food \$60.00 for a total of \$304.20. The reason I figured for 2 room nights is that I have no idea how long this meeting will last. As per their Advisory Policy the meetings will end at 6:00 PM. However, they can suspend the rules of the day and continue on as they did in Austin at this last meeting. This has been added since I emailed my report, if I only stay one night and with the current gas prices, I can do the trip for about \$220.00. I am presenting these projected costs for this in advance so that there will be no surprises at the November RSC when I ask to be reimbursed. Now I have to ask this question. Is this body OK with funding me to go to this meeting?

I have forwarded a copy of the TSCAB minutes to everyone. One of their major problems is that they start over every year with the Texas State Convention (TSC). Sound like a familiar problem? Therefore they are in the process of doing the same thing we are doing with our ad hoc convention subcommittee so that the information isn't lost. They have formed an ad hoc subcommittee to address these problems and have asked a member from each region to attend these meetings. I have no idea where these meetings will be held.

The TSC is growing each year. They booked close to 230 rooms in Dallas and their room block was 100 rooms. The next TSC will be in El Paso, Texas on Memorial Day in

2009. Austin won the bid for the next TSC in 2010. One of the continuous problems the TSC is addressing is getting rid of the bugs in their Convention Policy. Each year after their convention they address these issues, which is a good thing if you have and use an advisory board.

The final report for TSC in Dallas was turned in and reviewed at this meeting. The treasurers report took some time and really wasn't complete. I have a copy of the treasurer's report if anyone wants to see it. It appears that when all is said and done they will have made \$11,259.79 (number changed to \$10,201.12 in the minutes) in Dallas. This will give each area and region a split of a little \$1,049.24 if all of the numbers are correct in the treasurer's report. One of the different avenues that the Dallas convention tried this year was to out source their convention merchandise to a private vendor. This didn't do to well and cost them money. Their convention seed money is \$1,800. This is one of the reasons that they do so many fund raisers for the TSC. The seed money goal for the Advisory Board is \$9,500. They are currently at about \$4,500. I believe that the reasoning behind this is for back up in case the convention ever goes bust and the money is used mainly for operational costs of the Advisory Board.

I have only missed one of the TBR ad hoc convention committee meetings and that was do me attending the last TSCAB meeting in Austin on the same date.

Open Discussion-

The open discussion begins with the topic of our recordings. CTA wants recording in a timely fashion. I have something to bring up to the RSC as directed by my area, It is the issue of not receiving the minutes from the RSC in a timely fashion.

Kim says that we need to take care of ourselves.

As I explained to my area (CTA), I take the best notes I can, but I know that I miss stuff and being able to have the minutes to refer to and to provide to the members of my ASC would be very helpful in increasing communications between the two bodies. Without the minutes it makes it difficult for us to vote or form decisions as an area in regional matters. I'm not sure what the best course of action is, but something needs to change. Also I would like to ask the facilitator if he could get the agenda out sooner.

Fred Mac (HCANA) makes the proposal that we remove our current Recorder. The proposal is passed by consensus. The nomination process and election of a new recorder will be done during the elections portion of the Agenda. Tom K. reads the duties of the recorder.

Tom states that we spent \$1,800 sending Jerry to the Southern Zonal Forums (SZF) last year. Two RSC's ago Esperanza made the proposal to stop attending the SZF because information wasn't getting back to the GSR's.

Tom reads different solutions available to the RSC. Someone mentioned just print outs from the SZF. If we did prints outs we could get that from their website. We could go to a day and a half RSC or a 2 day RSC.

We need solutions for getting information from the Southern Zonal Forum (SZF) to the areas and groups. We spend \$1,800 to send the RDA to the SZF's last year.

Margret likes April's idea of wanting to learn how to conduct workshops and suggests workshops to be conducted by RD's and RCM's in order for the Rcm's to learn how to conduct workshops. This way the RCM's could learn to do workshops as the only way you learn is by doing it.

Ben C. from the North Side area states that their area is planning to this exactly as Margret stated and will bring this up in new business.

Dawn likes the suggestion, problem is that when people hear the word workshop they aren't fun. Do presentations at our convention.

Bill thinks we need to go to a 2 day RSC and use one of those days for workshops. We have been trying to do this for the past four years and it has been like beating a dead horse. We could take one of the days and have the RD & RDA do workshop and teach the RCM's how to conduct workshops so that they can take them back to their areas and do their job.

April agrees on the 2 day workshop idea. I came from a region where the RD & RDA worked with the RCM's while the subcommittees were meeting.

Tom talks about how we came from Lone Star Region and they had a 3 day RSC. Maybe a central location like (Victoria-cough) where we could get to the RSC later and use Saturday morning for drive time and not have to worry about a room Friday night. We have tried to get this going for 4 years and it hasn't worked. Our RD & RDA bring us a wealth of information and we need to put it to use.

Bob R. wants to go to a semi annual RSC that is a 2 day RSC. HASCONA does not want to go to a 2 day RSC.

Jackie asks 'isn't it the RCM's job to get the information from the region and take it back to their areas"? Her concern is doing double work. Tom states that we would be putting our RD's on the road a lot and that the travel costs would be expensive to send them to all of the areas.

Allen states that if he has everything to take back to his area his job as an RCM would be a lot easier and he is able to make sure his ASC knows everything that is going on. He doesn't believe his area would support a 2 day RSC.

Fred says that the RCM's in HCANA don't have a lot to report the 2 months after the RSC and maybe the RD's could come to our area to do some workshops. HCANA does not want a 2 day RSC. No way. Fred likes the idea of the RD or RDA coming out to our ASC where the GSR's are already there.

Jose wants to centralize the RSC so that we know where we are going every time. Dawn is willing to sit down with each area and get an 18 month schedule of the ASC's. She would be willing to get the information out to the ASC's, but not every Sunday of the month. Dawn is willing to do whatever works for the areas. Dawn believes that TBR being a part of SZF is a vital source of information for our region.

Jerry states that all information including old information is available in hard copy on the SZF website. These hard copies don't do any good unless we use the information in small groups as they do at the SZF.

April agrees and adds that we need a 2 day RSC and CD's from the SZF. She states that the website has not been updated in awhile. Each area needs copies of the SZF CD's. The CD's will help our areas grow. We need to step out and take a chance and learn.

RCM's want information from the SZF to take back to their areas and groups.

Bryan states that the DVD's or CD's along with a hard copy are a viable learning tool. Of course a workshop is better, the other is a good tool and could save us money and teach us a lot. When we pass information down the information changes.

Margaret states that addicts sharing with addicts has lost. My home has always been open to other addicts. We can stay with each other and save the cost of a hotel. We have done this in the past and I still do it. This is the way I have really gotten to know some people. Jerry L. states that people can stay at his home also. Maybe we should find a third place to meet for workshops. Maybe we could do workshop every other time or after each SZF. Allen says he completely supports that idea of having separate workshops and taking the information back to his area.

As per sending the Co-Facilitator to the TSCAB meetings, just send a report. All agree so reports will be sent by email. There is a lot of discussion and the bottom line is that we aren't getting that much out of the TSCAB. Kim states that we are getting low on funds. So the Co-Fac will send reports to the TSCAB. Bill wants to know what we are accomplishing by attending the TSCAB. Bob States that we aren't getting anything as our ad hoc subcommittee is far ahead of the TSCAB. The TSCAB has just had 5 members role off at the last TSCAB meeting. They want to form an ad hoc committee to work on their policy. So they have asked for 1 member from each region to attend. So this would add 2 to 4 more meetings a year.

RD and RDA question about attending Serenity in the Sand to do workshops that had been planned. Bill wants to know if anyone from RGV has contacted the RD or RDA about what they are supposed to do. April wants to call Rey V. to find out what is going on. Jerry M. takes issue as one person does not speak for an area. There is discussion if the hotel is even there due to the hurricane last month. Bill makes the proposal not to send the RD & RDA to South Padre. Proposal passed by consensus.

Rey is called in RGV and states hotel is ok and they weren't expecting TBR to come down to do the workshops.

Adopt an Inmate funding is canceled as per TBR Policy. They haven't sent TBR any receipts for the expenditures of the \$400 we send each quarter from the H & I budget. Bill states he hasn't seen a receipt in 4 years. April wants to know if we have ever received a receipt from Adopt an Inmate? We have received a report, but never a cost accounting for the \$400 we send them each quarter. No proposal is needed to stop funding Adopt an

Inmate as it is in policy on page 5. Adopt an Inmate has never been a part of this region. Tom says that we are not going to give adopt an inmate any more money until we get some financial accountability.

Sunny says "am I disagreeable? Hell yes". I will listen to your advice and if I am wrong I'll tell you.

Questions:

Jackie asks are you going to stay in this region? Yes my wife is going to have a baby. April asks what positions Sunny has served at the Convention level. He has been the hospitality Chair. April – Is there anything that would prevent you from being a co-signer on the convention account? No.

Tom states that Sunny doesn't have much convention experience. Sunny says that he has been talking to people that have in New Mexico and Texas. Tom asks if he is willing to scream help? Yes.

Bryan asks if a list of convention positions would help and Sunny answers Yes.

Tom asks if there are any people in Hill country who have convention experience.

Fred speaks up.

Mary W. speaks up.

Sunny is asked to leave the room.

Tom asks for comments.

Bob T, speaks up. Sunny just planned a function in Kerrville (ROAR) that blew his socks off. It takes a lot to impress me and I am very impressed with what they did. We have already had a bunch of people step from Esperanza and Central Texas that want to help us in 2010.

The CAC should be in place by 2010. When someone comes in our area with over 20 years clean I ask about them. I was told we were lucky to have him and he is a stand up kind of guy. This information was given to me by my sponsor.

Tom's concern is Hill Country Area is such a small area. The convention chair for 2009 does not have any NA Convention experience, but he has wrapped himself around people that have convention experience.

Allen says from what Bob has said there are people with convention experience who are willing to step and help.

Bill says that he has had the opportunity to talk to Sunny at RBS 2 or 3 times and the guy has something going. He states that Coastal Bend will be there to help too. This will be a god thing and it will turn out the way it is suppose to turn out. I don't think there is a problem with it as everyone will be on top of it.

Jerry M. says by not having convention experience will be good as he doesn't have a lot of baggage and it sounds like he is more than willing to ask for help.

Tom asks is there are any reservation about Hill Countries proposal to host the TBR Convention in 2010? There are no reservations. Proposal passes by consensus.

Sunny V. is elected the Convention Chair for 2010.

Central Texas proposes to change policy that subcommittee chairs are to only use Subcommittee funs for facility rental, travel, & literature. Any other expense must be brought before the RSC for approval.

Kim states that the subcommittee chairs are already funded for travel in our regional policy.

Mary W. asks about PSA's and Margaret states that PSA's are considered literature.

Jerry M. Can for see a circumstance where a workshop could be bigger than an area could handle.

Margaret says that anything else should be brought to the region for approval.

Tom asks if there are any reservations. There are none so proposal passes by consensus.

Proposal: RD, RDA, and RCM will do workshops in order to teach RCM's to conduct workshops.

Allen likes the idea of RD, RDA, & RCM's doing workshops to learn so that they can go back to their areas to conduct workshops.

Hill Country proposes that all the RCM's get transcripts from the SZF so that they can take them back to their area.

Tom asks Fred if there is a time limit on this proposal.

The RDA doesn't know when she will receive the transcript from the SZF.

Tom asks if everyone understands the proposal? Proposal is to require the RDA to make available all transcripts available from the SZF within a 6 week period after the SZF meeting.

There is a lot of discussion.

Tom asks if there are any reservations and there are none. Proposal passes by consensus.

Allen proposes that the RD & RDA put on a workshop for the RCM's.

Tom thinks this is a very good idea as we have been struggling with this for a while now.

Margaret questions whether the workshops are to teach the RCM's or to learn about the topics from the SZF. What is going to be the focus?

Tom replies both.

Allen says he needs more information so he knows what is going.

Jerry M. asks if the body would be ok if the RD Team and Admin body set the date.

Proposal: Require RDA to have all SZF transcripts available to all RCM's within 6 weeks of SZF. Proposal passed by consensus.

Date will be Saturday December 6th, 2008. Location will be at the RDA's discretion and will be announced.

Discussion on SZF copies of the CD's. Blank CD's cost about \$.18 a piece, so we need to find out about the copyrights before burning the CD's from the SZF.

Jackie says that GSR's or anyone is welcome to attend the workshop.

Proposal to send RD & RDA to the next SZF in New Orleans in September does not pass. There are 2 reservations to the proposal.

Kim states that we are spending 3 times more than we are taking in.

Meeting was closed with the Third Step prayer by Tom.

Meeting was adjourned at 5:12 PM.
