





Literature Review is more excited than usual!

The 'Living Clean' book is scheduled to be released between October and December 2012. A gift edition is scheduled to be released at the same time. As soon as more information is available I will let you know.

As a reminder, these are the Literature Review projects for the 2012-2014 cycle:

- 1. A Traditions book.
- 2. The conversion of the service pamphlet 'An Introduction to NA Meetings' to an IP.

Input and ideas for the Traditions book will be solicited in a similar way as the 'Living Clean' book. The goal is to have an 'approach for a book-length piece' ready to present at WSC 2014.

There will be a review and input period for 'An Introduction to NA Meetings' with an approval version scheduled to be in the 2014 CAR.

Both of these projects are opportunities for your voice to be heard. The plan for the Traditions book is happening because our voices were heard in the 2010 literature survey. The majority of respondents wanted a book-length piece of literature on the Traditions and now we're getting it. If this project progresses in the same way as 'Living Clean' did, it will be an exciting, uplifting and gratifying experience.

The 2011 membership survey had a record response of 17,492 members. Here are some of the results:

- \*Average length of clean time was 10.87 years
- \*Average age of members was 42.7
- \*47% of respondents were female and 53% were male
- \*Members attended an average of 3.24 meetings per week
- \*70% held service positions

Results are expected to be published in a pamphlet which should be available soon. However, you can see what looks like pages from the pamphlet at na.org. Select 'For the Public' tab. Click on 'Resources for Professionals' then select 'Membership Survey'.

In the July 2012 'NA Way' the editor wrote, 'the NA message is being carried in 77 languages in 129 countries in almost 62,000 meetings weekly.' She, or he, then went on to say, 'so why did we receive 'NA Way' submissions from only 22

countries in 2011?!'

Good question!

Literature Review isn't just about reviewing. As seen in the 'Living Clean' project it is also about submitting and sharing experience, strength and hope. So if you, or someone you know, is interested in contributing to the 'NA Way' or 'Reaching Out' please let me know. Or just e-mail your submissions to those publications. Contributions don't have to be written pieces, artwork is also accepted.

If you are interested in doing more than submitting NAWS plans to add new members to the editorial workgroups for both 'Reaching Out' and 'The NA Way'. This could be an exciting opportunity to participate in our literature creation. Contact the Human Resource Panel at na.org/hrp if you're interested.

Literature Review is looking forward to a busy cycle! As soon as the projects get started I will let you know.

#### SZF Notes 7/28/12

Change in agenda to include in times to accommodate "In times of illness" presentation to not have a break during the presentation.

#### Fellowship concerns

Louisiana – discussed how their convention funds the RSC. Ideas at their last meeting involving how to support the regional convention through area contribution. Areas hosting are now trying to have local members board speakers.

Lonestar – continued with the convention talk and their Region is funded 60% by their convention. Another issue involves filling positions at the RSC. Minutes had been late due to illness of their recorder. Provisions are being discussed to deal with this issue. All positions at the region are now filled although the apathy in service is still an issue.

Tejas – discussed the recent WSC. RD presented the outcome of workshops, voting, and Iran video. RSC was interested in SSP and what was going to happen to resolutions and straw polls that did not receive strong support and that if the SSP was to be presented at the next CAR then changes would need to be made to meet the 2/3 requirement. RDA presented a planning seminar that was well supported. Texas State convention idea to align with Tejas. TSC was very open to this idea and we are communicating with each other about how that could be best accomplished.

Volunteer – creating a calendar to accommodate the different service positions including PI, PL and website. Request concerning areas and regions as how they report in the new SSP and if any other regions use the resource pool in their regions or areas.

Mississippi – PR submitted packets to the Mississippi schools to addiction professionals. Handed out information to PD and court systems as well as medical professionals. Dealing with lack of interest from members concerning service.

Red River – Concerns on how to implement SSP. Retention or fulfillment of regional positions are continuing to be difficult.

Arkansas – Regional meeting fell in the middle of the WSC. At previous meeting all positions were filled and new area (South Arkansas Area) was created. South Arkansas area was actually a previously existing area that was re-established. Texarkana area is talking about moving to the Lonestar region. Areas support much of the services individually but the Region has offered to support the areas in any ways necessary.

Dan Red River – Apathy in service being a major difficulty. Long term recovery members seem to be more interested in going to the parties rather than doing the service work. Newcomers come in and see the promise that we have to offer but the older members are not getting involved.

Cathy Dallas – Focusing on PI committee working with the planning basics guide. Started an inventory with the H&I and PI committee. Hoping that by starting with the members they will take ownership of the process. Getting members to not only sign up but to show up. Creating a process that has a beginning and an ending could help to generate more participation.



#### What is the SZF

Presented by Dickie – copy of presentation is available upon request and is being posted on SZFNA.org. Calendar is developed now and available for all Regions, Areas and Groups to add event information. If we all utilized this website I think we could reduce overlapping of activities. It was also mentioned that we could add the website to our regional and area directories to build comfort with utilizing this website. It may be time to ask not what we are but what we could become. Checking other forum websites to determine what their focus has become. Southeast Zonal Forum has a symposium that happens once a year and puts on a PI presentation. Western States meets once a year. Midwest forum meets twice a year. Rocky Mountain forum meets twice a year. Plain States forum meets twice a year. Suggested doing an inventory or brainstorming session of what we can do next.

#### In Times of Illness

Presented by Matt and Lucy – copy of power point is available at NA.org website – for our members – issue discussion topics. Forum was separated into small work groups and discussed questions and answers based on the power point.

#### Summary of WSC

Presented by Cathy and Ron — All information had previously been presented by Dawn and myself at the last region. Question arose about how the WB would be dealing with resolutions or straw polls that did not gain strong support. The opinion of the members that attended was that we really would not know what the direction the workgroup would take on the support or non-support that was presented on the resolutions or straw polls until we see the final product of the SSP. The belief is that the workgroup would take the information that they were given and modify the SSP to meet the needs and desires of the fellowship as a whole based on the direction they received at the conference. Discussed how the RD's were going to move forward over the next cycle in presentation of the SSP as well as IDT's. Ideas included transferring WSC workshop experience to the different regions as well as workshops on the IDT's and new literature. Experiment with GSU — any format of how a non-decision making meeting can be implemented and what challenges or benefits are identified as a result of this installation. Experiment with other pieces of the SSP that seem would work in your area or region and provide information to World Services on how these ideas are working.

Sunday Business -

Show Me – Changed policy so that guideline and other recurring proposals be handled on an annual basis. Insurance for the region is moving forward. Most positions are filled at the RSC. WSC presentation was handled at the last region. Attitudes changed after the playing of the tape (Iran Video). Implementing the changes from the SSP will take a while to implement. CBDM is moving forward.

#### **Members Concerns**

Tom Show Me – Dealing with the RSO establishing their not for profit tax id. Their RSO handles much of the literature purchasing for the Arkansas Region. Upcoming RSO merchandise inventory is approaching and usually has 6-7 members helping in the process. Planning an outside audit for the RSO which serves 19 areas and 420 groups.

Pat Arkansas – HRP is planning to be moving up the notification process for WSC (WB, Facilitator, HRP) nominees by 6 months. Another change is for traditional candidates to process their questionnaire through their RSC's and Zones. Only 2 seats will be opening on the World Board at the next conference (one board member that will likely be nominated again and one new opening). Process for reviewing candidates will be arduous as the HRP tries to present about 4 candidates for the next cycle. Found that there was a glitch in the on line qualification process that showed World Board experience for members that checked the box for World Project experience.

Jerry Houston – PI subcommittee is doing well with a co-facilitator being elected last month. Maintaining the meeting schedule pretty well as well as the updates on the Area website. PL is staffed 24-7 by volunteer addicts, rolling phone service from one to another with very little effort although other avenues like "freedom voice" has been suggested which would automatically forward line based on computer programming. Harris County probation officers are utilizing our efforts to satisfy their requirements through our presentations to them every three or four months. Latest critiques from the grading officers have given us good to excellent reviews of our presentations. Looking to expand in the future to taking presentations into the school systems.

Nick Arkansas – Volunteers for service work are a concern. Presenting service opportunities as a fun experience rather than a chore would help.

Karen Living Clean - supporting her desire to be of service and attending to see the infrastructure works.

BJ Red River— Home group facing difficulty with seventh tradition donations. 800 in attendance monthly with a monthly income of about \$300. Apathy in service and lack of participation also an issue. Trying to make service attractive one member at a time.

Lee Living Clean – Members with five to ten years are showing up to meetings and ASC. PI and literature, would like to see more information into the racks of local treatment facilities. Need to get newcomers involved in service as well. May need PI and literature workshops.

Tress Mississippi Region – reiterated lack of members that want to be of service. Very few willing members getting involved. Those that were involved had gotten burned out and have fallen off. Merrygo-round cycle of trusted servants shifting positions.

#### Topics for next SZF in Ketuckiana

Serving our home groups through communication. SZF inventory – what can we do better. Project planning based system – Kristin and Matt. Collaboration. CBDM. Insurance – Rob and Mike. How can the serving structure better serve our home groups – Pat and Gary.

Potential for moving forum at end of January to Tejas to align with convention – showing members what the SZF is all about (based on what came out of the last inventory. Concerns with making a move at this time. That idea was reviewed and dismissed due to logistic challenges. Instead it was discussed holding the CAR workshop 2014 in Tejas at the SZF / Convention timeframe (if the convention committee is ok with the opportunity) Additionally if the convention and forum time line could align on the weekend of January 24<sup>th</sup> – 26<sup>th</sup> this could help the convention with additions to their room block.

Consensus was reached to make ourselves available to all SZF regions conventions in the future to present workshops on Planning Basics for this cycle and continue future cycles based on the IDT's or current issues.

Treasurer report -

Troubles with bank account as the bank has been changed since our last forum. We have had difficulty viewing bank statements for this period. There is a discrepancy of \$217.49 (in our favor) currently being review.

Administrative body was not aware that the facilitator would not be here. #### **CAC Report August RSC**

Hello Family,

We met last month after attending the Convention Committee meeting. We discussed the TBRSC Policy, TBRCNA Guideline and our own CAC Guidelines. From that discussion we have come up with these policitand changes to the respective guidelines. Most of these changes are needed to align practices already in place with our policy and guidelines. There is a spate sheet attached to this with those proposals.

The one proposal to change the TBRCNA to Labor Day weekend is because of booking challenges, weather, Hotel rates and the time of the year of this convention to the Christmas/New Year's holidays.

Year after year we are faced with having to move away from the first weekend of February. We have been in January through the third weekend of February. Rates during this time are always more because of the lack of availability of rooms at the Hotels.

Weather has caused us to have members drive in dangerous conditions and it has been a few other times when ice and snow was around on that weekend.

Rates are always higher when demand is high also. We face this every year being that February is one of the busiest times for conventions.

Having the convention so close to the Holidays has shown us that a lot of members will wait until the last minute to register or not go due to lack of funds from the Holidays.

Having said all this moving to Labor Day weekend will give us a better chance at good rates and locations and will not put us in conflict with other convention except for WCNA. Not holding the convention during a WCNA that is held in the US will allow the members to support our World Convention.

We are working on possibilities for the Coastal Bend/Ris Grande Zone's Hotel at this moment. We have one Hotel that doesn't have space available on the first weekend of February and the other is borderline on if has enough capacity for us. We are also looking at South Padre/Brownsville/McAllen as well for deals.

One of the other options we are looking at with the Corpus Christi CVB is the possibility of using their Convention Center for our convention and getting room blocks at local Hotels at a cheaper rate. More will be revealed about this as soon as we hear from the CVB
